

**22ND ANNUAL MEETING OF INTERNATIONAL NANTERRE NETWORK
AND
COLLOQUIUM "LAW AND INTERCULTURALISM / LAW AND CULTURAL CONFLICTS"
Porto, 7-10 June 2017**

I. GENERAL PROGRAM

***Wednesday 7 June 2017:** Arrival in Porto.

***Thursday 8 June:** Opening Ceremony of the 22nd Annual Meeting.

-Country by country Presentation (in English language):

-Reports by the delegations on the development of the international relations of their Law Schools, in particular the development with the partner universities of the International Network (Erasmus programs; Colloquiums; Joint Summer-, Autumn- or Winter Universities).

As every year, **universities, which are participating for the first time**, will be given the opportunity to present themselves (in particular their international activities) during the "Country by country Presentation" and to establish contacts with the delegations of universities with whom they want, for example, enter into an Erasmus partnership.

***Friday 9 June: Colloquium "Law and Interculturalism / law and cultural conflicts".**

***Saturday 10 June:**

-Morning: continuation and end of the Colloquium and Closing Ceremony of the 22nd Annual Meeting.

- Afternoon: cultural program or departure.

***CONFERENCE is FREE.**

***FINANCING:** As every year, the participants in our Annual Meeting **finance travel and stay from Erasmus funds or from their university's / faculty's own resources.**

-Registration for a lecture at the COLLOQUIUM 9 JUNE (20 minutes + discussion):

-No delegation is required to announce a lecture. An individual expert can participate.

-It is possible that several speakers belong to a delegation.

Required information for each speaker:

1° Name, title / function and mail address

2° Title of the lecture

3° Language of the lecture

The presentation can be in English or in another language – but in this case with a written translation in English distributed to the persons in the audience, who do not understand the language of the speaker.
