Isabelle Daugareilh is a CNRS research director. She is the Director of COMPTRASEC (Centre for Comparative Labour and Social Security Law), UMR CNRS 5114 at Bordeaux University. She is a specialist in international and comparative labour law and has been teaching in several Master's programmes at Bordeaux University and the Bordeaux Institute for Political Studies since 1990. She is an associate researcher at CRIMT (Interuniversity Research Centre on Globalization and Work) in Canada. She has worked with the European parliament as an expert on decent work in developing countries. In April 2017, she was a guest expert at ILO in the context of the organization's centenary: "*The future of work we want: a global dialogue – An ILO centenary Initiative -Work and Society.*" She was one of a group of experts brought together by ETUI-ETUC in June 2017 to reflect on a Scenario building: "*Shaping the digital economy 2030, From research to action.*"

Her research focuses on the social dimension of economic globalization, corporate social responsibility, the social impact of digitization of the economy, and international migration.

She is currently leading a research project funded by the Nouvelle Aquitaine Region on: "*The platform economy and its impact on work and organizations*" (2018-2021). She is also a partner in an international research project: "*Institutional experimentation for a better work*" (2017-2024), led by CRIMT and funded by SSRH in Canada. She coordinated a European research project on the corporate social responsibility of European multinationals in the context of the 6th FPRDT (ESTER 2004-2007). She directed research project funded by the Aquitaine region on: "*Corporate social responsibility, a vector for labour law in globalization*", October 2007-October 2012. She participated in the ANR led by Nicolas Postel (Clerse-Lille) on: "*Social responsibility and environmental enterprises: institutional transition or the return of paternalism?*" (RSTI – 2009-2012).

She has directed the publication of several books, including: "*CSR, a vector for labour law on globalization*" ed. Bruylant 2017, "*Social dialogue in the representative bodies of European transnational enterprises*", ed. PUB, 2013, and "*Social responsibility of transnational enterprises and economic globalization*", ed. Bruylant 2010. "*Globalization: work and*

fundamental rights", ed. Bruylant, 2005, "*International migration and the labour market*", ed. Chroniques social, Lyon, 2005, "*Lessons learned from a reduction in working hours*", ed. MSHA, Bordeaux, 2005. She is the author and co-author of articles published in French and international reviews on various aspects of globalization and the rights of foreign workers. She is currently preparing two composite publications: "*Access to social justice in comparative and international law*" (to be published by Bruylant in 2018) and "*Social security in international and comparative law*" (to be published by Pedone in 2018).
